REGENT OF BATANG,

Considering : That to implement the provisions of Article 116, paragraph (2) of Law Number 6 of 2014 on Villages, as last amended by Law Number 6 of 2023 on the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation into Law, and Article 29, paragraph (3) of Government Regulation Number 43 of 2014 on the Implementation of Law Number 6 of 2014 concerning Villages, as last amended by Government Regulation Number 11 of 2019 concerning the Second Amendment to Government Regulation Number 43 of 2014 on the Implementation of Law Number 6 of 2014 concerning Villages, it is necessary to stipulate a Regional Regulation concerning Village Designation;

CHAPTER T

GENERAL PROVISIONS

Article 1

In this Regional Regulation, the following terms shall mean:

- 1. Region refers to the Regency of Batang.
- 2. Regional Government refers to the Regent as the executive element of the Regional Government who leads the execution of governmental affairs under the authority of the autonomous region.
- 3. Regent refers to the Regent of Batang.
- 4. Village refers to a legal community unit with territorial boundaries that has the authority to regulate and manage governmental affairs, community interests, based on community initiatives, origin rights, and/or traditional rights recognized and respected within the governmental system of the Unitary State of the Republic of Indonesia.
- 5. Village Government refers to the administration of governmental affairs and community interests within the governmental system of the Unitary State of the Republic of Indonesia.



- 6. "Village Boundary" refers to the administrative boundary of a village, which is a series of coordinate points located on the earth's surface, which may include natural landmarks such as ridges or watersheds, river medians, and/or manmade markers in the field that are represented in a map.
- 7. "Village Boundary Designation" refers to the process of designating village boundaries cartometrically on a basic map that has been agreed upon.
- 8. "Village Boundary Demarcation" refers to the activity of determining the coordinate points of village boundaries through cartometric methods and/or field surveys, represented in a boundary map with a list of village boundary coordinate points.

Article 2

This Regional Regulation aims to provide clarity of status, legal certainty, and administrative order in the administration of village government in the Regency of Batang based on administrative data of the Village Government.

Article 3

The objectives of this Regional Regulation are:

- a. To recognize and respect existing villages in the Region with all their diversity; and
- b. To empower village communities as the subjects of development.



CHAPTER II

SCOPE

Article 4

The scope of this Regional Regulation includes:

- a. Village designation; and
- b. Village boundary designation, demarcation, and validation.

CHAPTER III

VILLAGE DESIGNATION

Article 5

- (1) The Regional Government designates 239 (two hundred thirtynine) villages located in 15 (fifteen) sub-districts within the Region.
- (2) Each village shall have a village code in accordance with applicable laws and regulations.
- (3) The villages referred to in paragraph (1) are listed in the appendix, which is an integral part of this Regional Regulation.

CHAPTER IV

VILLAGE BOUNDARY DEMARCATION AND VALIDATION

Article 6

(1) The Regional Government shall conduct the designation, demarcation, and validation of village boundaries in accordance with applicable laws and regulations.



(2) Further provisions regarding Village Boundary Designation,

Demarcation, and Validation as referred to in paragraph (1)

shall be regulated by a Regent Regulation.

CHAPTER V

TRANSITIONAL PROVISIONS

Village boundaries established before the enactment of this Regional Regulation shall remain valid until the designation and demarcation of village boundaries in accordance with this Regional Regulation.

CHAPTER VI

CLOSING PROVISIONS

Article 8

Regent Regulations as implementing regulations of this Regional Regulation shall be stipulated no later than 1 (one) year from the enactment of this Regional Regulation.

Article 9

This Regional Regulation shall take effect on the date of its promulgation.

To ensure that everyone is informed, this Regional Regulation shall be promulgated by placing it in the Regional Gazette of the Regency of Batang.

I. GENERAL

This Regional Regulation is an implementation of the provisions of Article 116, paragraph (2) of Law Number 6 of 2014 on Villages, as last amended by Law Number 6 of 2023 on the Stipulation of Government Regulation in Lieu of Law Job Creation Number 2 of 2022 concerning into Additionally, this Regional Regulation also implements Article 29, paragraph (3) of Government Regulation Number 43 of 2014 on the Implementation of Law Number 6 of 2014 concerning Villages, as last amended by Government Regulation 11 of 2019 concerning the Second Amendment to Number Government Regulation Number 43 of 2014 on the Implementation of Law Number 6 of 2014 concerning Villages.

This Regional Regulation concerning Village Designation, which includes the designation, demarcation, and validation of village boundaries, and the assignment of village codes in accordance with applicable regulations, aims to provide clarity of status, legal certainty, and administrative order in the administration of village government in the Regency



of Batang as part of the village's authority in development. This Regional Regulation is a legal instrument that recognizes and respects existing villages in all their diversity to realize progressive, independent, and prosperous villages in accordance with the village's identity, while simultaneously empowering the village communities as subjects of development in Batang Regency.
